Góðan daginn,

I am writing you regarding the future potential production of laxakvíar in Ísafjörður.

We, KJ, have in the past 3-4 years been coming to Ísafjörður to build laxakvíar for Salmon farmers in the Westfjords.

Various production areas have been tested. From those experiences we have been thinking about what a good area would look like. From that we have made an example of a area that we think would be very well suited for this application.

The salmon industry is constantly moving forward, and equipment constantly needs to be built, rebuilt and refurbished. The demand for laxakvíar is constantly growing. We, KJ, therefore present this proposal as a good potential site where we could produce cages.

I am of course not familiar with the future plans for this area, but hopefully this area is available in the future.
